Sarah Hippensteel, Miami Conservancy District, was present along with Mike Ekberg to give an update on Conservancy activities.

Ms. Hippensteel stated that the Miami Conservancy District was created as a result of the 1913 flood of the Great Miami River. She stated that the District protects communities in southwest Ohio from flooding, preserves the quality and quantity of water, and promotes the enjoyment of our waterway as it relates to the Great Miami River.

She then stated the top four activities as follows:

- 1. Dam Safety Program the Dam Safety Initiative capital improvements program began in 1999 to upgrade the safety of the five dams along the river. The program was completed last week.
- 2. Levy Accreditation All levees have been accredited by FEMA.
- 3. Water Resources Program Mr. Ekberg discussed the aquifer and water protection efforts
- 4. Recreation Activities The District works with local communities to actively promote tourism of the waterways through marketing and communication of recreational amenities throughout the Great Miami River Watershed by branding and marketing regionally.
